

LIMITED WARRANTY

HM Digital, Inc. ("the Company") products are warranted to the purchaser against defective materials and workmanship.

Length of Warranty:

The following products are covered under the Company's warranty for three (3) years: TDS-3, TDS-4, TDS-4TM, TM-1, DM-1, DM-2, CT-1, PS-100, PC-100, PS-200, PS-202, SP-1, SP-3.

The following products are covered under the Company's warranty for two (2) years: TDS-EZ.

The following products are covered under the Company's warranty for one (1) year: COM-100, PH-200, PR-1.

As of October 11, 2006, the PR-2 will no longer include a warranty. The warranty for PR-2 units purchased prior to October 11, 2006 will be honored until the warranty's expiration date.

Third-party products not manufactured by HM Digital and products deemed by HM Digital to be accessories, including, but not limited to batteries, fittings, spare rods and calibration solutions are not covered under HM Digital's warranty.

What is covered: Repair parts and labor, or replacement at the Company's option. Transportation charges for repaired or new product to be returned to the purchaser.

What is not covered: Transportation charges for the defective product to be sent to the Company. Any consequential damages, incidental damages, or incidental expenses, including damages to property. This includes damages from abuse or improper maintenance such as tampering, wear and tear, water damage, or any other physical damage. The Company's products are not waterproof and should not be fully submerged in water. Products with any evidence of such damage will not be repaired or replaced. See additional note below. (NOTE - The COM-100 and PH-200 are watertight and completely submersible. Please ensure that the battery compartment and probe gasket ring are firmly tightened before submersing in water. The warranty does not cover water damage to the COM-100 or PH-200 due to parts not securely closed.)

Implied Warranties: Any implied warranties, including implied warranties of merchantability and fitness for a particular purpose, are limited in duration to five years from date of purchase. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. To the extent any provision of this warranty is prohibited by federal and state law and cannot be preempted, it shall not be applicable. This warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.

NOTE: Warranties are product-specific. Third-party products and products deemed by HM Digital as "accessories" are not covered under warranty. Third-party products include, but are not limited to, batteries and fittings. Accessories include, but are not limited to, precipitator rods, fuses and product cases.
